AECCI NEWS CENTRE

One of AECCI's main objectives is to keep its members and the business community updated with the economic developments, business opportunities and facilities. The Headlines during last quarter are below:

July, 2016: India is framing its own organic products policy

In order to promote Indian export of agriculture and processed food from the country, Govt. is framing its own Organic Product Policy with clearly prescribed safety standards, traceability norms, soil certification Guidelines and good agricultural practices.

July, 2016: CBEC is planning to go paperless

Imports will become easier as from the next year the CBEC is planning to move towards a completely integrated customs system for facilitating documentation and fast-tracking clearances of consignments. It will do away with requirement of any physical documents.

July, 2016: No subsidy is provided on the export of cow meat

According to the existing foreign trade policy, export of beef (meat of cows, oxen and calves) is prohibited and No subsidy is provided on the export of cow meat.

Aug, 2016: India has signed a MOU with Mozambique to import 3,75,000 tonnes of pulses during 2016-19.

This MOU fixes targets of minimum quantities of import of Tur and other pulses from Mozambique over three financial years.

Aug, 2016: The government has introduced duty drawback of 3.2 per cent to 4.7 per cent

(depending on the category) for exports of non-fabric inputs made from imported fabrics under special advance authorization scheme.

Aug, 2016: Export duty benefits to save onion growers

The Centre has recently offered onion exporters a 5 per cent grant under the Foreign Trade Policy's Merchandise Exports from India Scheme (MEIS) to boost export.

Sep , 2016:Flour mills have inked deals to import 8.25 lakh tonnes of wheat from Australia, France and the Ukraine.

As per Millers they could have imported more wheat if the government reduced the import duty on it to 10 per cent from the existing 25 per cent or removed it completely.

Sep , 2016:Mexico emerges as top destination for Indian auto exports

It is followed by Nepal and the United Kingdom at a very distant second and third position, respectively.

Sep , 2016:Collapse of Hanjin puts Indian seafood exporters in a fix.

South Korean container shipper Hanjin filed for bankruptcy. The collapse of Hanjin has left many Indian seafood exporters worried as how their shipments will reach to customers.
