# INDIA AIMS TO DIVERSIFY EXPORT MARKETS AMID GEOPOLITICAL SHIFTS

The Indian government is developing a plan to diversify its export destinations and boost shipments of products like electronics, pharmaceuticals, engineering goods, and food items to new markets.

This move comes as trade with traditional partners such as the United States and Europe declines due to geopolitical realignments caused by regional conflicts.



India's export expansion targets regions like Saudi Arabia, France, Vietnam, the Netherlands, and Mexico, Ethiopia, beyond traditional food moving commodities. Product diversification includes electronics, pharmaceuticals, foods, processed and alcoholic beverages, guided by market research to navigate trends and regulations. This strategy aims to mitigate geopolitical risks, lessen dependence on traditional trade partners, and unlock new avenues for growth.



# RUSSIAN EXPORTERS SPEND \$4 BILLION ON PURCHASE OF INDIAN MADE ARMS IN RUPEES

Russian exporters who had accumulated around USD 8 billion in special rupee Vostro accounts for trade with India have recently utilised nearly USD 4 billion of those funds to purchase Indian-made defence equipment, armaments, and other imports, as well as Indian securities.

The Vostro accounts were set up by the Reserve Bank of India last year to facilitate trade between Russia and India using Indian rupees, amid Western sanctions on Moscow.






Indian exporters have faced limited investment opportunities, leaving funds in Vostro accounts unspent. Russian exporters have utilized 50% of the USD 8 billion accumulated in the last six months for imports from India and investments, such as government treasury bills. India increased imports of discounted Russian crude oil amid the Ukraine conflict and exported machinery and auto parts worth over USD 4 billion to Russia in 2023. Both nations are collaborating to address the buildup of rupee payments in Vostro accounts and facilitate bilateral trade settlement using the accumulated funds.




