






# INDIAN EXPORTS TO DOUBLE BY 2030 TO USD 835 BN RIDING ON ELECTRONICS, SEMICONDUCTORS, AUTO, SOLAR ENERGY, PHARMA & DEFENCE

India and Vietnam have emerged as the biggest beneficiaries of the ongoing shifts in global supply chains, as multinational corporations adopt a "China+1" strategy to diversify their manufacturing bases beyond China, according to a report by equity research and rating firm Nomura.



A report suggests India's exports may double by 2030 due to factors like supply chain diversification, the China+1 strategy, and a 10% annual growth rate. Nomura's analysis ties this growth to domestic India's market and key projects in various sectors. US and developed Asia investments are important, benefiting industries such as electronics, autos, solar pharmaceuticals, and defense. Vietnam is also expected to benefit from the global shift away from China.



# MORBI CERAMIC EXPORTS BRACE FOR IMPACT AS US MULLS ANTI-DUMPING DUTIES

Morbi, India's renowned ceramics manufacturing hub, is bracing for a potential blow to its export business as the United States considers imposing anti-dumping duties on ceramic tile imports from India.

The move has already led to a significant disruption in orders, with manufacturers reporting that at least 25 percent of orders from the US have been halted, and more cancellations are anticipated.





Morbi's ceramic industry faces challenges from duty hikes by Gulf Cooperation Council nations and a slowdown in European countries. The US market, a key export destination, is threatened by potential antidumping duties on Indian ceramic tile imports.


This has led to a halt in dispatches to the US, impacting orders. Morbi exports products worth USD 2.3 billion annually to over 180 countries, with the US accounting for 8-9%. The ongoing supply chain crisis adds to uncertainties for Morbi's ceramic manufacturers.
