## INDIA'S PHARMA EXPORTS POISED FOR RECORD GROWTH OF USD 31 BN IN FY25

India's pharmaceutical exports are expected to surge over 11 per cent to a record USD 31 billion in the fiscal year 2024-25, propelled by multiple factors including drug shortages in the key U.S. market, according to a top official from the exporters' body under the Commerce Ministry.



India's pharmaceutical exports for the fiscal year ended March 2024 increased by 9.6% to USD 27.8 billion, with over 50% going to North America and Europe. Despite global challenges, exports to the U.S. and the U.K. rose significantly. Quality drugs at affordable prices will keep India competitive. Challenges include geopolitical tensions, economic slowdown, and quality issues. Demand for Indian exports is expected to rise due to generic drug shortages in the U.S. and increased shipments to Africa. Pharma exports grew in most markets, with a 7% increase in April 2024.

# MORBI CERAMIC EXPORTS BRACE FOR IMPACT AS US MULLS ANTI-DUMPING DUTIES

Morbi, India's renowned ceramics manufacturing hub, is bracing for a potential blow to its export business as the United States considers imposing anti-dumping duties on ceramic tile imports from India.

The move has already led to a significant disruption in orders, with manufacturers reporting that at least 25 percent of orders from the US have been halted, and more cancellations are anticipated.



Morbi's ceramic industry faces challenges from duty hikes by Gulf Cooperation Council nations and a slowdown in European countries. The US market, a key export destination, is threatened by potential anti-dumping duties on Indian ceramic tile imports.

This has led to a halt in dispatches to the US, impacting orders. Morbi exports products worth USD 2.3 billion annually to over 180 countries, with the US accounting for 8-9%. The ongoing supply chain crisis adds to uncertainties for Morbi's ceramic manufacturers.

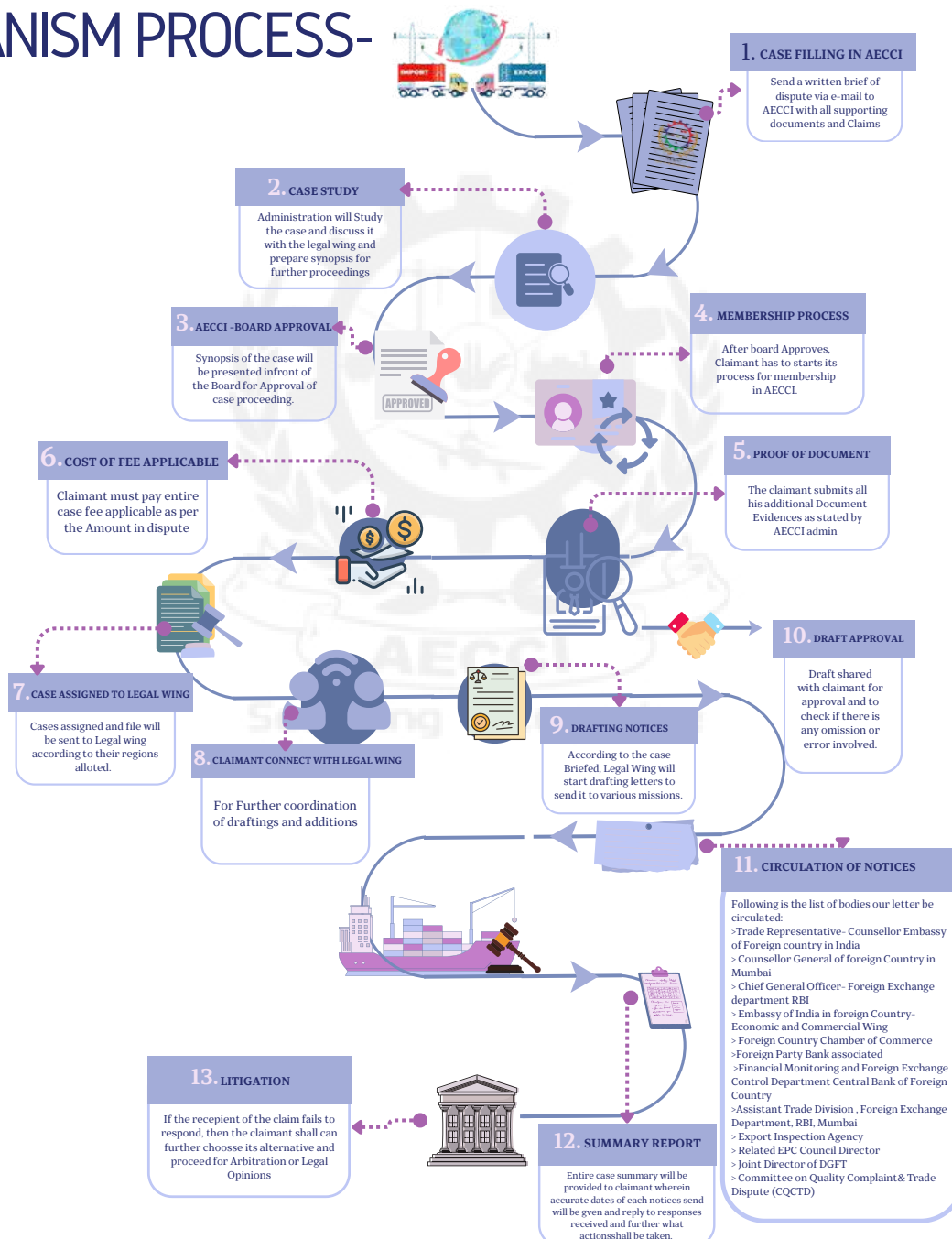

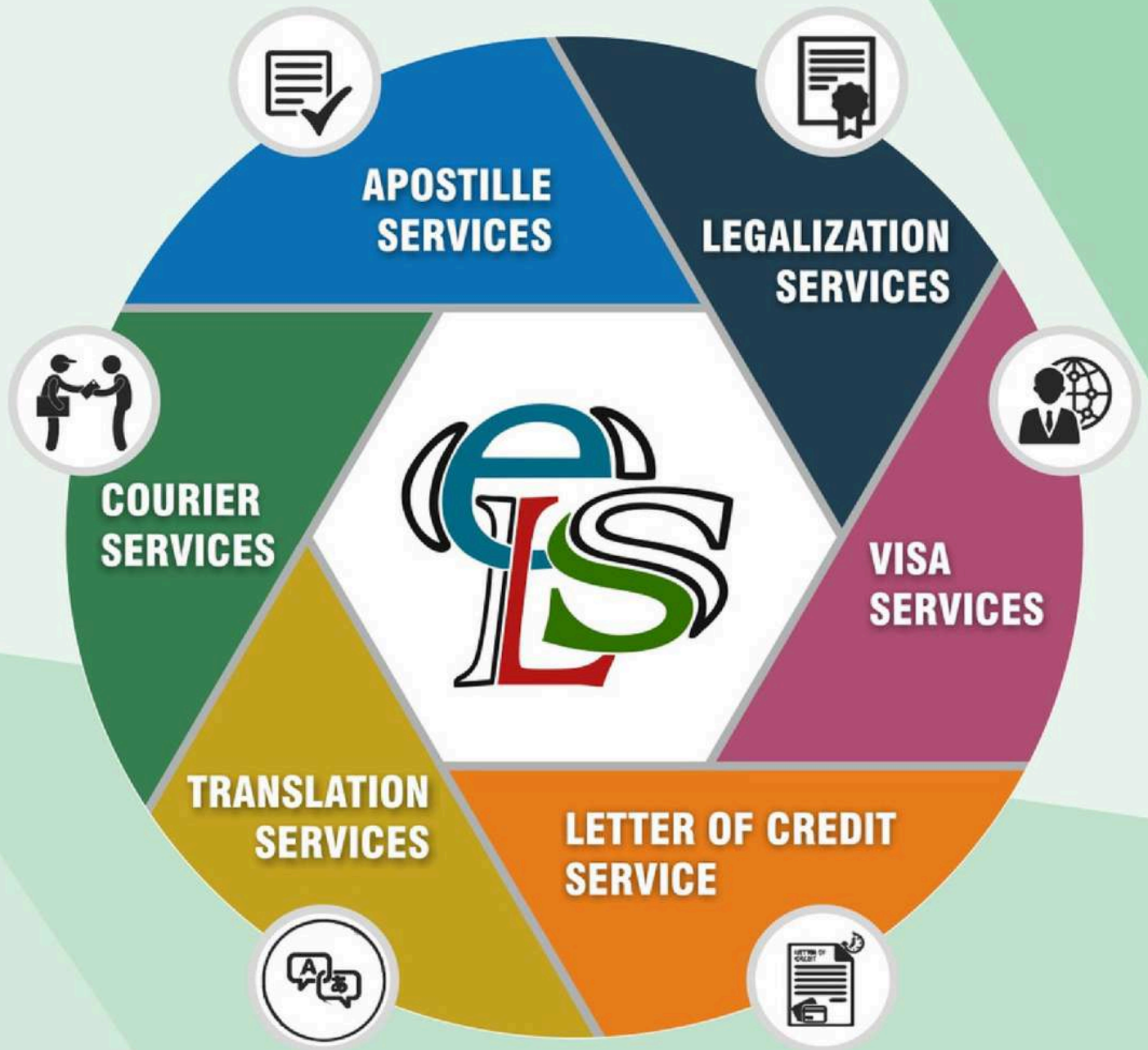
