



APPLE IPHONE EXPORTS FROM INDIA NEARLY DOUBLE IN APRIL

Apple has kicked off its fiscal year 2025 with a remarkable surge in iPhone exports from India. Official data shows that exports of iPhones manufactured in the country nearly doubled in April 2024 to USD 1.1 billion, compared to USD 580 million in the same month last year, reported ET. Analysts find the jump notable as April typically sees subdued global export activity due to a lack of major sales events.



Apple is making strides in India, aiming for a 1 trillion rupee export milestone this fiscal year. India is becoming Apple's second-largest iPhone manufacturing hub after China. Estimates show 14-15% of iPhone production has moved to India, expected to reach 26% by 2026. Apple's 2024 production in India hit a record \$14 billion, with over \$10 billion in exports. Apple works with Foxconn, Wistron, and Pegatron under India's production-linked incentive scheme.





COTTON EXPORTS FROM INDIA PROJECTED TO RISE 27% IN 2023-24

The Cotton Association of India (CAI) has estimated that cotton exports from the country will increase by around 27 percent to 28 lakh bales during the 2023-24 crop year ending September.

This is higher than the 22 lakh bales exported in the previous 2022-23 crop season. According to CAI President Atul Ganatra, the demand for Indian cotton went up as prices ruled 8-10 percent lower than international prices from December 2023 to March 2024. Major export destinations include Bangladesh, China, and Vietnam.





CAI estimates India's cotton production for 2023-24 at 309.70 lakh bales, with total supply until April 2024 at 315.86 lakh bales.

Domestic consumption is projected at 192.50 lakh bales, with exports at 21.50 lakh bales.


The ending stock for April is forecasted at 101.86 lakh bales. For the full season, total cotton supply is estimated at 359 lakh bales, including imports of 20.40 lakh bales.


