

# INDIAN STEELMAKERS FEAR IMPORT SURGE AFTER U.S. TARIFFS ON CHINA

India's steel industry is bracing for a potential flood of imports from China after the United States imposed steep tariffs on Chinese steel and aluminium this week, industry representatives said on Wednesday.

The Indian Steel Association (ISA), whose members include major producers like JSW Steel and Tata Steel, warned that the U.S. tariff hike has made India "highly vulnerable to surging and predatory imports" from China.



Indian steelmakers face challenges from increasing Chinese steel imports which have nearly doubled.

India turned into a net importer of finished steel due to competitive rates. Tariff-related measures may be considered if domestic prices drop sharply, but action might be delayed until after the general election concludes on June 4.





# INDIAN AUTOMAKERS FIND EXPORT MARKETS FOR SMALLER CARS AS DOMESTIC DEMAND SHIFTS

Indian automakers like Maruti Suzuki, Hyundai, Kia, Citroen, Volkswagen, Honda, Nissan and Renault are increasingly finding export markets for their smaller, compact car models even as domestic consumer demand shifts towards SUVs and larger, feature-packed vehicles.

Once dominating India's passenger vehicle market with a nearly 50 per cent share, the small car segment now accounts for less than 30 per cent of total sales as SUV trends have significantly impacted sales of compact cars and sedans in recent years.





Small cars' market share in India decreased from 47.4% in 2017-18 to 46.5% in 2019-20. However, there is high demand for these cars in export markets like South Africa and Saudi Arabia.

Maruti Suzuki and Hyundai export small cars. Executives expect a revival of small car demand in India by 2026-27 due to increasing affordability and upgrades.


Despite SUV popularity, automakers foresee opportunities in both export markets and a rebound in the small car segment in India.


