

## US TARIFFS ON CHINESE SOLAR IMPORTS OPEN DOOR FOR INDIA

US President Joe Biden's decision this week to sharply increase tariffs on USD 18 billion worth of imports from China, including a hike on solar equipment from 25 per cent to 50 per cent, is expected to provide a major boost to India's plans to become a global solar manufacturing hub.

The fresh round of trade sanctions against China will see tariffs rise across several sectors like steel, aluminium, semiconductors, electric vehicles, and batteries by 2024-2026.



India is set to benefit from US tariffs on Chinese solar imports, leveraging its industrial antistrong base and dumping measures, says Gyanesh Vikram Solar. ## INDIA TO IMPOSE STRICTER SCRUTINY ON EV INVESTMENTS FROM NEIGHBOURS LIKE CHINA

India will draw up additional guidelines for investments under its new electric vehicle (EV) policy announced in March, according to a government official.

Applications from auto companies based in countries sharing a land border with India, such as China, will face "much more onerous scrutiny."

The move comes as Tesla CEO Elon Musk cancelled a highly anticipated visit to India last month after postponing it at the last minute, citing "very heavy Tesla obligations."





Elon Musk's meeting with Prime Minister Narendra Modi was replaced by a surprise trip to China. The EV policy in India aims to attract investments through duty concessions for manufacturing units with a minimum investment of \$500 million. Companies can import limited vehicles costing over \$35,000 at a 15% duty while ramping up local production.


The guidelines will include application portals and a monitoring agency, with initial consultations held by the heavy industries ministry. India's cautious approach towards China amid geopolitical tensions is evident in the scrutiny of EV investments.
