## COMMERCE MINISTRY TO LAUNCH E-CONNECT PLATFORM FOR SMALL EXPORTERS

The Indian Commerce Ministry is set to introduce an e-connect platform aimed at providing small exporters with crucial information on duties and other trade-related matters, a senior official announced on Friday.

The initiative is part of the government's efforts to promote ease of doing business through digitisation and streamlined procedures.



Director General of Foreign Trade Santosh Kumar Sarangi discussed the e-connect portal providing exporters with trade information. FIEO highlighted e-commerce export potential and partnerships. Optimism was expressed for exceeding \$900 billion in exports, but concerns were raised about the Red Sea crisis impact on export competitiveness and freight rates. Infrastructure issues affecting exports to Bangladesh were also addressed. The e-connect platform aims to support small exporters and improve India's global trade position through technology and streamlined processes.

# INDIAN EXPORTS NEED 12.5% CAGR TO MEET 2030 TARGET, SAYS FIEO CHIEF

Federation of Indian Export Organisations (FIEO) Director General and CEO Ajay Sahai has stated that Indian exports must grow at a Compound Annual Growth Rate (CAGR) of 12.5 per cent to achieve the USD 2 trillion export target by 2030.

This assessment comes as current growth rates fall short of the required pace.

During a meeting with FIEO members in Kolkata, attended by Directorate General of Foreign Trade (DGFT) official SK Sarangi, Sahai presented an analysis of India's export performance.



Exports grew at 8.2% CAGR from 2018 to 2024 but may not meet the 2030 goal. Recent export values were USD 778B in 2023-24, USD 776B in 2022-23, and USD 676B in 2021-22.

The Red Sea crisis impacted exports. Capital-intensive sectors like electronics saw strong growth, but labour-intensive sectors like footwear lagged. India signed 19 FTAs and is negotiating more.

Strategic interventions and sector-specific approaches are needed to boost export performance.

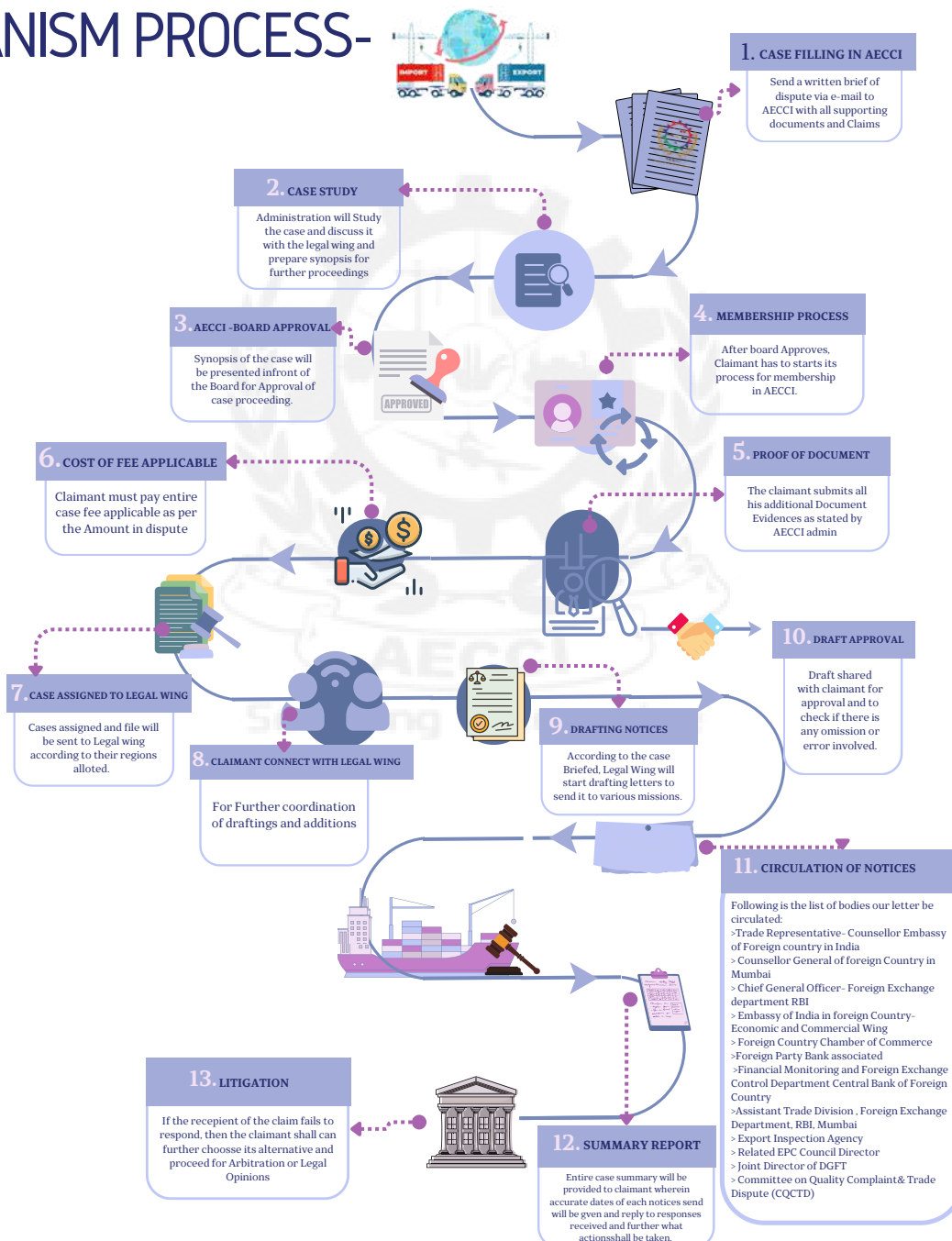
