CABINET MINISTER PIYUSH GOYAL TAKES CHARGE AMID EXPORT DECLINE

Bharatiya Janata Party leader Piyush Goyal has been reappointed as Cabinet Minister after winning the Mumbai North constituency in the recent elections.

In the third term of Prime Minister Narendra Modi's government, Goyal will continue overseeing the Ministry of Commerce and Industry.

However, he has had to relinquish other portfolios including Consumer Affairs, Food and Public Distribution, and Textiles that he handled previously.



Piyush Goyal, a 59-year-old chartered accountant turned politician, has held various ministerial positions in India's government.

He oversaw ministries like Power, Railways, Commerce & Industry, and Finance. Goyal led initiatives such as e-auctioning coal mines and power sector reforms. As Commerce Minister, he signed trade agreements and settled disputes.

INDORE TOPS MP IN EXPORTS WORTH OVER RS 20,000 CR

Indore emerged as the leading exporter in Madhya Pradesh for the financial year 2023-24, with outbound shipments worth over Rs 20,000 crore.

The city's exports grew by 12 per cent year-on-year, reaching Rs 20,256 crore, driven primarily by medicines, textiles, and engineering products.

According to data from the office of the Joint Director General of Foreign Trade, Dhar ranked second in the state with exports valued at Rs 10,973 crore, a slight increase from the previous year.



The pharmaceutical industry was a significant contributor to Dhar's exports, with Madhya Pradesh's total exports in the 2023-24 fiscal year at Rs 65,255 crore.

The pharmaceutical sector, led by Indore and Dhar, played a crucial role, with pharmaceutical product exports from the state amounting to Rs 13,158 crore.

Medicines, soy, cotton, and engineering products showed good growth in exports. Indore and Dhar had notable medicine exports, while the Malwa-Nimar region saw increased soybean meal exports.

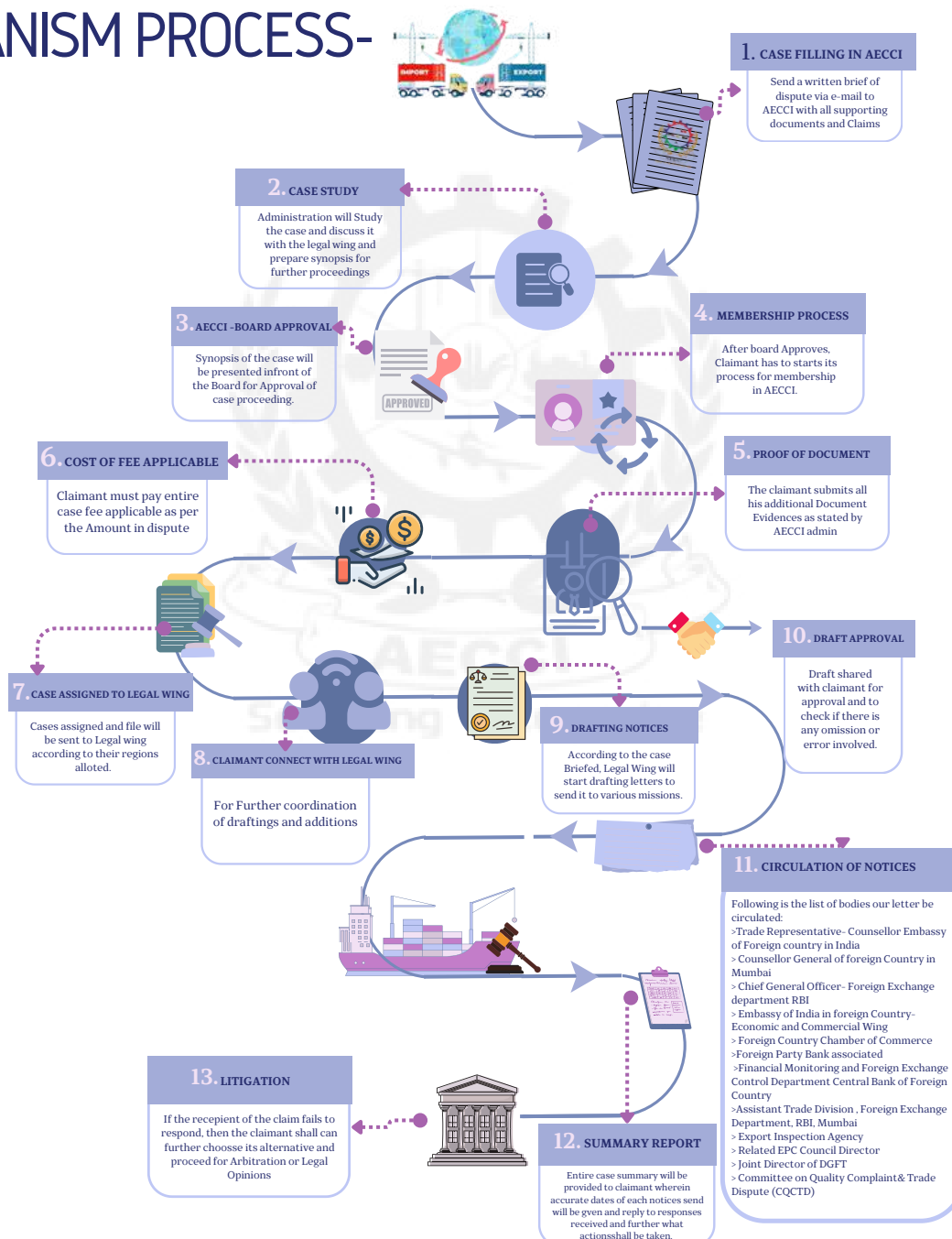
