

# INDIA'S STEEL EXPORTS TO EUROPE HIT 5-YEAR HIGH IN FY24 AMID CHALLENGES

India's steel exports to Europe soared to a five-year high of 3.3 million tonnes in the fiscal year 2023-24, a remarkable 65 per cent year-over-year increase and nearly doubling from fiscal 2019-20 levels.

However, this surge in European exports masks challenges Indian steelmakers face in other key markets. While shipments to the European Union were buoyed by factors like sanctions on Russia and reduced competition from China, Indian mills lost ground in the United Arab Emirates and Southeast Asia due to intense Chinese export competition.

Indian steel exports increased by 11% in 2023-24, driven by demand European countries like Italy, Belgium, Challenges included and Spain. competition from cheaper Chinese Vietnam the UAE, exports in and disrupted trade with Turkey due to geopolitical tensions, and slow sales to Southeast Asia and the Middle East. Indian mills are focusing on the domestic market due to pricing challenges against Chinese and Japanese suppliers.







# GOVT UNVEILS RS 10,000 CRORE AI MISSION TO BOOST TECH INNOVATION

In major push to drive innovation in artificial intelligence (AI) and emerging technologies, Indian government the unveiled an ambitious Rs 10,000 mission aimed crore developing robust ΑI ecosystem in the country.

The core objective of this mission is to establish a network of state-of-the-art data centres equipped with high-performance computing facilities, which will be leased to industry players, start-ups, academia, and researchers.







Data centres will house advanced infrastructure like GPUs, aiding in training large language models. government plans to manufacture AI chipsets locally with global partners. The mission aims to reduce computing costs for AI start-ups by 40-50% and includes initiatives like funding for innovation centers, Al datasets start-ups, platform, and AI applications in sectors like healthcare and agriculture. It will also focus on developing indigenous AI models and tools, promoting ethical AI, and increasing AI courses in educational institutions for skill development.


