

# INDIA'S PETROLEUM PRODUCT EXPORTS REBOUND MARGINALLY IN MAY

The government plans to create IndTrade for trade promotion and a national branding division to boost exports to \$2 trillion by 2030. Currently, 14 export promotion councils and FIEO operate under the Department of Commerce to support exporters.



IndTrade aims to enhance "Made in India" branding with targeted campaigns and a label scheme. Plans include doubling exports in six years trillion and reaching \$8 by 2047. Strategies involve strengthening overseas market links, digitizing trade processes, and prioritizing Free Trade (FTAs) to boost export Agreements growth. The government focuses on trade negotiations, developing SOPs for FTAs, and exploring logistics corridors like the India-Middle East-Europe corridor and the Chabahar port deal in Iran.

#### Subject: Amendment in Appendix - 6B of FTP/HBP,2023. Regarding

In exercise of the powers conferred under Paragraphs 1.03 and 2.04 of the Foreign Trade Policy, 2023, the Director General of Foreign Trade hereby amends Para 10 (ii) of Appendix – 6B of FTP/ HBP, 2023. The amendment in Appendix 6B is as follows:

#### Effect of this Public Notice:

To bring parity with provisions of Chapter 4 of the FTP/HBP regarding value addition for spices covered under Chapter 9 of the ITC(HS) Code, the provisions of Chapter 6 of the FTP/HBP (Appendix 6B) are being amended to the extent that in the case of spices, a minimum value addition of 25% shall have to be fulfilled only where both export as well as import item pertains to Chapter 9 of ITC(HS) Code. In all other cases, the value addition will be 15%.

## **INDIA LIFTS BAN ON ONION EXPORTS**

The government on Saturday lifted the ban on onion exports subject to a minimum export price of USD 550 per tonne, a decision that can help boost income of a large section of farmers and comes ahead of the Lok Sabha polls in key producing regions including Maharashtra.

The government has imposed a minimum export price (MEP) of USD 550 per tonne (around ₹ 46 per kg) as well as 40 per cent export duty. Taking duty into account, the shipments will not be allowed below USD 770 per tonne (around ₹ 64 per kg).





The Indian government lifted the ban on onion exports to stabilize prices, setting a minimum export price.

This decision, influenced by comfortable supply and stable prices, aims to support farmers in key onion-producing regions. The move considers domestic demand, global market conditions, and the upcoming monsoon forecast, intending to encourage increased onion cultivation.


The government is procuring 5 lakh tonnes of onions as buffer stock to manage price rises. An inter-ministerial committee continuously monitors and takes steps for essential food items. This year's onion production is estimated at 254.73 lakh tonnes, a drop from last year. Recently, 99,150 tonnes of onions were exported to neighboring countries.
