

In a significant development, the Netherlands has emerged as India's third largest export destination, after the United States and the United Arab Emirates, during the 2023-24 fiscal year.

Notification No. 15 /2024-25 New Delhi, Dated: 5th June, 2024

Subject: Export of food commodities through National Cooperative Exports Limited (NCEL)

S.O. (E). - In exercise of powers conferred by Section 3 read with Section 5 of the Foreign Trade (Development & Regulation) Act, 1992 (No. 22 of 1992), as amended, read with Para 1.02 and 2.01 of the Foreign Trade Policy, 2023, the Central Government amends Notification No. 46 dated 30.11.2023 specific to the export of Broken Rice to Senegal and Gambia through NCEL, as under: -

The time period for export of Broken rice to Senegal and Gambia for the quantity notified vide Notification No. 46 dated 30.11.2023 has been further extended for 6 months, till 30th November 2024.

Effect of the Notification:

Notification No. 46 dated 30.11.2023 has been amended to the extent that the period for export of Broken rice for the quantity already notified vide notification no. 46 dated 30.11.2023 specific to Senegal and Gambia through NCEL has been extended for further 6 months up to 30th November, 2024. Rest of the Notification No 46 dated 30.11.2023 remains unchanged.

INDIA'S PALM OIL IMPORTS SURGE TO 4-MONTH HIGH IN MAY

India's palm oil imports rose sharply in May, jumping 12.4 percent from April to reach 769,000 metric tons, the highest level in four months, according to estimates from five industry dealers.

The surge in purchases by the world's biggest importer of vegetable oils was driven by a recent correction in palm oil prices, making it more attractive compared to rivals like soy oil and sunflower oil.





This could lend support to the benchmark Malaysian palm oil futures contract, which fell to a more than three-month low in May.

Palm oil imports surged due to higher margins, with refined palm oil imports increasing to 214,000 tons.

Crude palm oil is competitively priced at USD 948 per metric ton, while sunflower and soyoil are higher.

India's palm oil purchases are expected to remain strong, with sunflower oil imports rising but soyoil imports dropping.


Overall, India's total edible oil imports increased by 15% in May to 1.5 million tons, sourced mainly from Indonesia, Malaysia, Thailand, Argentina, Brazil, Russia, and Ukraine.
