




TATA ELECTRONICS' BENGALURU CENTRE BEGINS EXPORTING SEMICONDUCTOR CHIPS

In a step towards boosting India's semiconductor capabilities, Tata Electronics Ltd, a Tata Group company has begun exporting limited quantities of semiconductor chips packaged at its pilot line in Bengaluru, according to industry sources.

These packaged chips are being shipped to some of Tata Electronics' partners in Japan, the United States, and Europe, reported ET.

This development comes as the company lays the groundwork for its new chip packaging unit in Morigaon, Assam, and a USD 10 billion chip foundry in Dholera, Gujarat.



Tata Electronics is progressing with semiconductor chip tape-out in various nodes. The chips, designed for multiple uses, are expected to enter commercial production by 2027. То showcase capabilities, robust for processes design, testing, and quality assurance essential. Tata is are Group collaborating with PSMC for a foundry in Dholera and establishing an OSAT unit in Assam. Their operations are expected to be on a larger scale than current players in India.

INDIA IMPROVES QUALITY ASSURANCE FOR PHARMA EXPORTS; BENCHMARKS WITH WHO NORMS

In a bid to bolster global confidence in the quality and safety of pharmaceutical exports from India, the country's drug regulator is undertaking a gradual overhaul of the approvals process.

The move comes in response to concerns raised by global authorities over the quality and safety of medicines shipped from India, reported Mint.





India is upgrading its Pharmaceutical Product Certificate to align with WHO standards for exporting pharmaceuticals. The CDSCO plans to publish these certificates online for transparency.

State governments can issue CoPP certificates only with CDSCO involvement. DCGI mandates adherence to WHO guidelines for quality products.




