

INDIA EXTENDS BROKEN RICE EXPORT WINDOW TO SENEGAL & GAMBIA UNTIL NOVEMBER

India has granted a six-month extension allowing exports of broken rice to Senegal and Gambia through November 30, 2024, according to a notification issued by the Directorate General of Foreign Trade on Friday.

after The move comes the banned outbound government broken rice shipments of in 2022 September to augment domestic supplies.

However, the ban was amended in May 2023 to permit exports on a case-by-case basis to nations facing food security challenges upon request from their governments.





India extended approval to export broken rice to Senegal and Gambia via NCEL until November 30, 2024, aiming to meet food security needs.

The policy change ensures adequate domestic rice stocks while addressing humanitarian requirements.


Data on approved exports to the two nations is not yet available. The government monitors supply and global prices to adjust export policies.
