

INDIAN GARMENT EXPORTERS EYE UK FTA AMIDST DECLINING TEXTILE EXPORTS

Indian garment exporters are pinning their hopes on a potential free trade agreement (FTA) with the United Kingdom to revive their fortunes, as the country's textile and apparel exports have declined for two consecutive years.

The industry is buoyed by the success of recently concluded FTAs with Mauritius and Australia, which saw a significant jump in readymade garment exports by 16.8 per cent and 5.7 per cent, respectively, in the first eight months of the current fiscal year.



Sudhir Sekhri, Chairman of AEPC, is optimistic about a potential deal with the UK. India's textile exports have declined, prompting AEPC to implement strategies like participating in global trade fairs and hosting 'Bharat Tex' exhibition. Ministry of **Textiles** emphasizes closer collaboration, capacity expansion, and adherence to international standards to boost garment exports. Indian exporters are proactive in reviving the sector and regaining global market position.



INDIA'S TOY EXPORTS WITNESS A MARGINAL DECLINE IN FY'24 DESPITE QUALITY CONTROL EFFORTS

India's toy exports witnessed a marginal decline in the financial year 2023-24, slipping to USD 152.34 million from USD 153.89 million in the previous fiscal year, according to a report by the economic think tank Global Trade Research Initiative (GTRI). The report highlights that India's toy exports did not significantly the mandatory benefit from control orders (QCO) quality the implemented to boost domestic industry and ensure safety standards.






India's toy industry faces challenges despite efforts to curb substandard imports from China. Toy exports saw a modest increase but declined in FY'2024, while imports rose. GTRI Founder noted the need for a comprehensive strategy to boost exports, including developing a strong domestic ecosystem, encouraging global brands to manufacture in India, and investing in research and innovation. The report suggests creating specialized manufacturing hubs, modernizing traditional toys, supporting small enterprises in marketing, and inviting international manufacturers up production facilities in India.


