## Export duty on parboiled rice may be fixed at \$100/tonne

The government considers imposing a \$100 per tonne export duty on parboiled rice to prevent under-invoicing by exporters avoiding the current 20% levy. A committee, Rice Federation Consulting Committee, was formed to address rice export issues. The 20% export duty was initially imposed to maintain domestic stock and control prices until October 2023, later extended till March 2022. Some exporters under-invoice to lower duty payments, leading to discontent over the proposed fixed export duty.






## INDIA TO REVIEW ZERO-TARIFF CONCESSIONS ON MOBILE PHONE IMPORTS IN ASEAN TRADE AGREEMENT TALKS

In a significant development, India is set to reassess the zero-tariff concessions granted on mobile phone imports during the upcoming review of its free trade agreement (FTA) with the Association of Southeast Asian Nations (ASEAN).

The talks, scheduled for July 29-31 in Jakarta, Indonesia, aim to modernize the ASEAN Trade in Goods Agreement (ATIGA) signed over a decade ago.

A high-ranking delegation led by Rajesh Aggarwal, Additional Secretary, Commerce Ministry, will represent India in these negotiations.




India plans to finalize a deal addressing tariff concessions for ASEAN countries, particularly Vietnam. The move aims to India's and boost domestic protect industries. The ATIGA agreement proposed tariff elimination for 74.2% of tariff lines. India's trade with ASEAN has increased significantly, yet it heavily favors the ASEAN region. Trade dynamics show India imports raw materials like coal and palm oil, while exporting petroleum products, vehicles, and more. India's approach of a single tariff schedule for all ASEAN members differs from the EU's individual member tariffs under FTAs, raising concerns about the effectiveness of India's strategy.
