PHARMACEUTICAL INDUSTRY URGES TAX INCENTIVES AND REDUCED IMPORT TARIFFS IN UPCOMING BUDGET

The pharmaceutical industry is advocating for increased tax incentives, reduced import tariffs on raw materials, and streamlined tax refund procedures ahead of the upcoming union budget. The Pharmaceuticals Export Promotion Council of India (Pharmexcil) has made several key recommendations, including reducing the basic customs duty on imported raw materials for antibiotic production from 7.5% to 5% and doubling the allowable deduction for research expenditure.




Pharmexcil aims to simplify tax refunds on raw materials to address low profit margins and high API prices in the pharmaceutical industry. While reducing import duties may lower costs for formulation manufacturers, it could impact domestic API producers. India imports pharmaceutical raw materials and exports finished products, with bulk drugs comprising over 55% of imports. The industry is monitoring the budget for potential policy changes affecting growth and competitiveness.


