






# GOVERNMENT EXTENDS INTEREST EQUALISATION SCHEME FOR MSMES BY TWO MONTHS

In a move aimed at supporting the country's export sector, the Commerce Ministry has announced a two-month extension of the Interest Equalisation Scheme (IES) for Micro, Small & Medium Enterprises (MSME) exporters.

The scheme, which was set to expire on Sunday, will now continue until August, providing pre and post-shipment rupee export credit to eligible businesses.



DGFT extended the Interest Equalisation Scheme (IES) for MSME exporters with a capped outlay of Rs 750 crore.

The scheme, aimed at easing financial stress on exporters, provides reduced interest rate loans with government compensation.

The extension has received mixed industry reactions, with concerns raised about its impact on non-MSME exporters.



# INDIA'S TEXTILE EXPORTS SURGE 5.4% IN FY 2025 FIRST TWO MONTHS

India's textile exports have shown significant growth in the first two months of fiscal year 2025, according to recent data from the commerce ministry.

The sector recorded exports worth USD 5.86 billion in April-May 2024, marking a 5.4 per cent increase from the USD 5.56 billion reported in the same period last year.

Cotton yarn, fabrics, and handloom products exports rose by 8.24 per cent to USD 1.95 billion, while readymade garment exports increased by 4.47 per cent to USD 2.55 billion.





Handcrafts and handmade carpets export growth reached USD 273.66 million, driven by post-pandemic recovery, increased demand for sustainable Indian garments, and European market interest.

Germany, Sweden, and Spain showed notable import increases. The Indian government plans to expand incentives for the textile sector to boost exports, attract investments, create jobs, and increase technical textiles exports.


Challenges include logistics and rising freight rates, but with government support, the sector is positioned for global market growth.
